

**SECTION 2**  
**MEMBERSHIP**

2.13 ALL MEMBERS OF THE CBA ARE BOUND BY THE CONSTITUTION AND BY-LAWS OF THE CBA AND BY THE BY-LAWS AND/OR AMENDMENTS WHICH MAY BE PASSED AT ANY FUTURE DATE OR PUT INTO FORCE AND EFFECT AT ANY FUTURE DATE AND BY THE BY-LAWS, RULES AND REGULATIONS FOR BURIAL IN EITHER OF THE BETH-EL CEMETERY, CEDAR PARK CEMETERY AND NEW CEDAR PARK CEMETERY OF BERGEN COUNTY, NEW JERSEY, AND/OR ANY OTHER CEMETERY IN WHICH THE CBA MAY HOLD LAND IN THE FUTURE.

**SECTION 6**  
**FUNERAL BENEFITS**

6.2 EVERY MEMBER IN GOOD STANDING OF CARDOZO LODGE AT THE TIME OF HIS DEATH IS ENTITLED TO INTERMENT IN THE GROUNDS OF THE CBA IN AN "IN LINE PLOT" EXCEPT AS OTHERWISE PROVIDED BY SECTION 2.13 ABOVE OR SECTION 6.6 BELOW.

6.3 THE WIFE AND CHILDREN OF A MEMBER IN GOOD STANDING OF CARDOZO LODGE SHALL BE ENTITLED TO INTERMENT IN THE BURIAL GROUNDS OF THE CBA IN AN "IN LINE PLOT" EXCEPT AS OTHERWISE PROVIDED BY SECTION 2.13 ABOVE.

6.4 IF AN INDIVIDUAL IS A MEMBER IN GOOD STANDING OF CARDOZO LODGE, AND IF SAID MEMBER, HIS WIFE OR CHILDREN BECOME DECEASED WHO DO NOT AVAIL THEMSELVES OF THE "IN LINE PLOT", THE DECEDENT'S ESTATE IS ENTITLED TO A FIFTY (\$50.00) DOLLAR REFUND EXCEPT AS PROVIDED IN SECTION 6.6 BELOW.

6.6 IF INTERNMENT IN THE GROUNDS OF THE CBA IS NOT PERMITTED DUE TO RELIGIOUS REASONS THE DECEASED MEMBER'S FAMILY SHALL RECEIVE A CASH PAYMENT OF \$450 WHICH INCLUDES THE \$400 VALUE OF THE IN-LINE GRAVE AND THE \$50 ENTITLEMENT AS PROVIDED IN SECTION 6.4 ABOVE.

**SECTION 7**  
**BURIAL PLOTS**

7.1 MEMBERS IN GOOD STANDING OF CARDOZO LODGE MAY PURCHASE RESERVED PLOTS IN CBA OWNED CEMETERIES EXCEPT AS OTHERWISE PROVIDED BY SECTION 2.13 ABOVE. THE FULL PRICE OF THE PLOT MUST BE PAID PRIOR TO ANY INTERNMENT IN SAID PLOT.

7.3 IN THE EVENT THAT EITHER A MEMBER IN GOOD STANDING OF CARDOZO LODGE OR HIS WIFE IS INTERRED IN AN "IN LINE PLOT" , THE REMAINING SPOUSE MAY RESERVE THE ADJACENT PLOT, EXCEPT AS OTHERWISE PROVIDED BY SECTION 2.13 ABOVE, FOR HIMSELF OR HERSELF AT THE THEN PREVAILING RATE, PROVIDING THE ADJACENT PLOT IS AVAILABLE.

**SECTION 8**  
**DEATH BENEFITS**

8.1 THE ESTATE OF EACH MEMBER IN GOOD STANDING OF CARDOZO LODGE, OR HIS WIFE, SHALL BE ENTITLED TO THE SUM OF \$100.00 AS A DEATH BENEFIT.

8.2 THE ESTATE OF A WIDOW OF A DECEASED MEMBER WHO HAS COMPLIED WITH SECTION 2.13 SHALL BE ENTITLED TO A 100.00 DEATH BENEFIT.

**BURIAL PLOT CONDITIONAL AGREEMENT**

7.1 MEMBERS IN GOOD STANDING OF CARDOZO LODGE MAY PURCHASE RESERVED PLOTS IN CBA OWNED CEMETERIES EXCEPT AS OTHERWISE PROVIDED BY SECTION 2.13 ABOVE. THE FULL PRICE OF THE PLOT MUST BE PAID PRIOR TO ANY INTERNMENT IN SAID PLOT.

7.2 ALL MONUMENTS IN NEW CEDAR PARK, CEDAR PARK AND BETH-EL CEMETERIES OF THE CBA MUST CONFORM TO CEMETERY RULES AND REGULATIONS.

7.3 IN THE EVENT THAT EITHER A MEMBER IN GOOD STANDING OF CARDOZO LODGE OR HIS WIFE IS INTERRED IN AN "IN LINE PLOT" , THE REMAINING SPOUSE MAY RESERVE THE ADJACENT PLOT, EXCEPT AS OTHERWISE PROVIDED BY SECTION 2.13 ABOVE, FOR HIMSELF OR HERSELF AT THE THEN PREVAILING RATE, PROVIDING THE ADJACENT PLOT IS AVAILABLE.

7.4 AN OWNER OF A CBA PLOT, NOT IN GOOD STANDING OF CARDOZO LODGE, SHALL HAVE THE USE OF HIS PLOT, PROVIDED THE PLOT IS PAID IN FULL.

7.5 NO PLOT OWNER MAY TRANSFER TITLE TO HIS PLOT TO ANYONE. HOWEVER, UPON APPLICATION TO THE BOARD OF DIRECTORS OF THE CBA, AND IN THE ABSENCE OF ANY CURRENT BURIAL IN THE PLOT, THE CBA MAY AT IT'S DISCRETION AND UPON A VOTE OF THE MAJORITY OF THE BOARD OF DIRECTORS, REPURCHASE THE PLOT FOR THE ORIGINAL PRICE LESS ALL APPLICABLE FEES AND TAXES.
